## CLERGY REPORT

The most far reaching change of 2014 came with Brian Robertson announcing his retirement.

Having come to Trinity and the Ashby and Breedon Team in 2005 we have effectively settled down into a pattern of ministry which saw me mostly working in Trinity and the town, with Brian overseeing S. Helen's and S. Mary's and John Dawson ministering to the four churches of the United Benefice of Breedon and Worthington.

For the last five years or so, I have been leading services in the United Benefice of Breedon and Worthington, on the fourth Sunday of the month.

All this has worked on the basis of John Dawson giving his time as a Self-Supporting Minister (He is not paid by the church of England).

With Brian's retirement the time came for a review, and increasingly I have found myself supporting the churches across the team as we entered into a time of interregnum (a time between Ministers).

I came to Holy Trinity, in no small part, because of what I had heard about Brian Robertson. Again and again, as I lived in Leicester I heard about this man who had ministered in three churches and one mission organisation based in the city. He was someone I wanted to work with. His preaching, love of God's word, care for others and team working were all spoken of warmly.

When an opportunity came to look at the post of Team Vicar in the Ashby and Breedon Team (with special responsibility for Holy Trinity) ministering alongside Brian, I wondered if this was God's leading.

The last nine years, being based primarily at Holy Trinity, have been an amazing season of seeing God's grace at work. We have come to love so many people within and beyond the churches, and said fond farewells to more than a few, but also found a community where we feel more at home than at any other time.

I am profoundly grateful to God for Brian's ministry to me and care for me. When I found myself facing new challenges and uncertainties he was rock-like providing advice and guidance.

In the last couple of years, we have seen God take us beyond the comfort of church services and familiar activities into new ventures, often reaching people in need. Following on from the launch of Street Pastors (led by S. Helen's church), came the CAP Money Course, Debt Help and Job Club with the Ashby foodbank serving so many people in crisis with food. These ventures have drawn us into deeper partnership with neighbouring churches and Christians and many others from across our town.

Towards the end of 2012 and in early 2013, we were joined by Stephen and Stella Brook and Paul and Geraldine Harris. After a good period of settling in following Paul and Stephen's retirement from full-time ministry as Church of England Vicar's, both have taken on an increasing visible role in leading services in 2014.

Alongside the appointment of Adele Adshead as our NSM (Non-Stipendiary Minister) Curate in July we have seen a great increase in the number of clergy who can lead services at Holy Trinity. They have brought with them a wonderful depth of godliness, wisdom, energy and creativity.

In particular, 2014 has seen Stephen and Stella Brook leading (with the Holywell Life Group) an Alpha Course that became the basis for the First Holy Trinity Pastorate. This mid-size group, which meets on alternate Thursday's in church, has added a whole new dimension to our church life. Stella has also taken oversight of our God Rocks Café with Paul Harris leading a new Key Stage 3 Group on Sunday mornings. On Sunday evenings, Paul Marcus-Smith has led our Key Stage 4 Group, alongside his wife Sandy, who started Soul Café at the beginning of the year.

The Autumn of 2014 also saw the first AMG (Ashby Men's Group) event led by Tony Bull. Other groups have also been formed and some of our long-standing ones have, with sadness and gratitude, come to an end.

When Adele was first appointed I spent a lot of time emphasising that her posting with us was for Adele's training rather than being 'an extra pair of hands', or to 'lighten the load of the Vicar'. While this remains the case it has been a joy to see Adele bring creativity, prayerfulness and grace to everything she plays a part in.

The preparations for Brian's successor as Team Rector of a team with seven churches, and just two paid posts, have led me into many new experiences. I have loved taking services and preaching in very different settings, while getting to know many new people. This has meant I have spent less time at Trinity in the morning services, but have also seen with joy a growing number of people attending church and them growing in faith under the ministry of so many others.

To conclude this annual report I want to ask again the question: Why? Why do we do all this?

There is one answer that is simple and profound: The Kingdom.

Jesus came proclaiming that the Kingdom of God was at hand. This kingdom is within reach, and we are seeing God's will being done on earth as it is in heaven. Bit by bit, we are being changed. Step by step, we are following in his footsteps.

We are the people of the Spirit of God. We are those who carry his presence wherever we go. This is the kingdom. This is the rule and reign of Jesus. And this is, of course, what all Christians are here for. Along the way there is a more particular call that I would like to outline for you. These words have focussed my thinking and praying for some years now:

*To be a community of love  
that shows the way  
enabling generations of servants  
to become the servants of all*

My prayer and my joy is to see us growing as a community of love that reveals something of what following Jesus looks like. We are together nurturing young lives (as well as welcoming and nurturing many older ones), and sending them out - in due time - to serve God where ever he takes them. This is a kingdom vision. This is a ministry that reaches to the far flung areas of the world.

My prayer is that Trinity would be a sending church. Nurturing, teaching, training and growing disciples of Jesus. Equipping the saints to serve our Lord and they then go on to train others to do the same.

This is a kingdom vision, where we all have a part to play. This is an invitation to all, those who are near and those who are far, that in our broken world we may bring the light of Christ.

In the autumn we saw adult baptisms, confirmations and receptions. Members of our family at Trinity being welcomed into the worldwide family of the Anglican communion. God is on the move. We have a part to play. He has much more for us. All we need to do is to keep in step with His Spirit.

# CHURCHWARDENS' REPORT

First of all, a big thank you to the many people who have served Trinity during this year in so many ways, such as leading worship, the administration of communion, reading lessons, leading intercessions, sidespersons and stewards, refreshments, operating the audio/visual system, cleaning the brass, compiling and delivering the church magazine, assisting in maintaining the church building, etc. The list is endless and if someone, or something, has been omitted please accept our apologies. Your help, encouragement and prayers have been greatly valued.

We are very grateful to Philip Craner, our vergers and hall caretaker, who has continued to complete his duties to his usual high standard.

As the PCC of Holy Trinity is a registered charity (Reg No 1131178), we are required to submit annual reports to the Charity Commission. Copies of those reports, which include the annual financial report, can be viewed by accessing the Charity Commission website.

## Deputy churchwardens

We are blessed with a wonderful team of Deputy Churchwardens (Frank Bedford, Bob Williams, Janet Onions, Steve Porter and Jean J Harrison) who have served us throughout the year in specific roles.

## Church family and growth

The people making up the congregation of Holy Trinity come from a wide range of Christian backgrounds - some worshipping at their parish church, others drawn by its particular spirituality, but all sharing a sense of Trinity being their spiritual home and place of growth. They are comfortable with the present style of worship, value its bible-based preaching and consider the friendliness and sense of "family" as one of the church's most significant and valuable characteristics.

We have continued to see growth in many areas of our church life, which is covered in detail within the various sections of this Annual Report. Every year we are required to provide certain statistical information to the Diocese relating to church attendance and our worshipping community, and the following brief extracts may be of interest. Figures for the previous three years are included. The figures given for the Worshipping Community should be seen as best indications.

### Use of the church building

We actively encourage the use of the church as a community building, and the church has been used for many services/concerts throughout the year, including:

- Remembrance Concert
- Ashby Concert Band
- School Harvest Services
- School Carol Concerts

as well as our regular users including Tiny Tots, Mothers’ Union, Trinity Fellowship, Pastorate Group, Boys on Fire, Soul Café and CAP Job Club.

The charges for use (other than worship) of the church by the various organisations who use the building are intended to recoup the costs incurred, for example, heating, lighting, verger’s time, etc., and obtain a donation to church funds for the volunteers from the congregation, without whom the events could not take place. No charges are levied for worship events and there are reduced charges for organisations raising funds for charitable reasons. The concerts are well attended and provide links between the church and the town community and also support a range of charities.

The charges levied remained unchanged from the previous year and were:

### **God Rocks Café (Junior Church)**

Many thanks go to our team of leaders, headed by Stella Brooks, who have been assisted by helpers from the congregation and have continued to bring our young church members to know Jesus, and learn that you can have fun being a Christian. The members of God Rocks Café once again participated in the Nativity Service and thanks go to them and Sandra Harris who led the team for that event.

### **General Information**

The pages of the Memorial Book were turned weekly, and additions made as appropriate; any such requests to be made via the Churchwardens or Tim.

The insurance policy, which provides cover to Holy Trinity in respect of employer's and public liability, church buildings and contents, was renewed and displayed in the vestry.

Maintenance of the churchyard falls on the Town Council which, since 1<sup>st</sup> January 2012, has used its own grounds-keeping staff.

Diana Saunders has continued to oversee communications within, and outside, the church. We continue to welcome contributions to the church magazine. Our thanks go to our Vicar and Emma Harris for the production of the magazine, and to Graham Barge for collation and production of this Annual Report which sets out Trinity's mission in Ashby and elsewhere (and other material printed over the year).

Copies of the church magazine are freely available to visitors of the church.

Our thanks go to Emma Harris who has continued to serve as parish administrator. Emma maintains the church diary (also available on our church website [trinityclose.net](http://trinityclose.net)), updates the church pew leaflets on a weekly basis, and runs the parish office on four mornings each week (Monday to Thursday) during school term times. Emma also agreed to serve S. Helen's in the same role as a consequence of the Team Rector's (Rev'd Brain Robertson) retirement during the latter part of 2014.

### **Church building maintenance/improvement**

Many thanks go to the persons involved in carrying out various small repairs within the church building. The church has suffered from water ingress at various points through the roof for some time. New proposals have been drawn up to address the problems posed. However, further funds are required before the work can be carried out.

### **Fund raising**

We have been very fortunate in having a committed team of fund raisers led by Carole Timms, ably supported by her husband Rod.

A Christmas Fayre was held to raise funds for the roof programme and CAP Foodbank.

### **Safeguarding of children, young people and vulnerable adults**

Trinity has Safeguarding Policies in place for children and young people and vulnerable adults.

### **Church hall**

Our thanks go to Phyl Hambleton for continuing to liaise with church hall users and bookings and undertake day-to-day management of the hall. The hall is run as a stand-alone facility and as such is a self-funding community asset.

The hall continues to be used on a regular basis by Trinity Play Group (who are not part of Trinity Church), Badminton, Army Cadets, Thursday Ladies (gentle exercise) and Dancing Classes.

## PARISH ADMINISTRATION

The Church Office encounters a number of varied bookings and requests for church use which focus particularly on weddings, baptisms and funerals which are also known as 'Occasional Offices'.

The weekly activities for the office administrator include:-

- Communication with congregation (by post / email / telephone)
- Dealing with a wide variety of queries related to Holy Trinity services, the booking of baptisms, funerals, weddings and concerts
- Entry into registers and production of copy wedding certificates
- Invoicing for church hire, weddings, funerals
- Production of weekly pewsheets
- Preparation of items for the Trinity Life Magazine
- Liaison with Holy Trinity volunteers for additional services
- Ordering of supplies
- Calendar administration
- Ensuring value for money on gas, electricity, phone, broadband and fire equipment servicing
- Rota generation
- Assisting with recruitment
- Policy generation
- Calculation of payments for retired ministers where necessary
- Occasional media (cards, invitations) for Refresh and Hope and Remembrance services.

Following the retirement of Brian Robertson (Rector of S. Helen's), the Administrator of Holy Trinity was approached by the Wardens of S. Helen's to assist in the cover of some of the administrative duties at S. Helen's from October 2014 onwards. This has included being central contact for enquiries via phone, email and post, photocopying of pew sheet and service sheets, all wedding administration (including S. Mary's and S. John's Coleorton). This has led to additional hours being worked (funded by S. Helen's) in order to manage the significant increase in workload.

## COMMUNICATIONS

At Holy Trinity, we all work as a team and we aim collaboratively to communicate clearly to everyone all that is happening in and throughout our church. Our intention is to provide the level of information people feel they need, whether they are internet-able or not. We rely on feedback to improve our communication network - so please do talk to us.

### Church Office

The Church Office is the main hub of our communications network. In September 2012 Emma Harris took over the church office. Emma has been in the church office (based in the vicarage) from 09:30 - 11:30 a.m. Monday to Thursday, taking telephone messages, carrying out general administration for the church and managing the church diary. During church office hours Emma can be reached on 01530 412339. We appreciate her efficiency and hard work. She is an excellent communicator! Following Brian Robertson's retirement in the Autumn, Emma took on four hours a week extra work to support S. Helen's church, which S. Helen's pays for.

### Church Diary

The church diary shows events taking place in the church building. Other groups taking place can be shown in the diary if requested. The diary is live and can be accessed through [trinityashby.net](http://trinityashby.net) or directly as a Google calendar.

### Church magazine

Copies of our monthly magazine, Trinity Life, continue to be available and can be delivered at a cost of £5 per year. Copies of the magazine are freely available for visitors in the church porch and at the back of church. Production of the magazine relies on a dedicated team to whom we are all grateful. We particularly thank all those who deliver the magazines to people in the parish and who, at the same time, provide a link with members of our church community.

## **Pew Sheets**

These are available weekly at all Sunday services. There has been little change in 2014, except for a gradual increase in detail. Large print pew sheets are available for those who need them.

## **Prayer Chain**

This is in regular use and in 2014 has continued to be a valuable communications tool. ## **Notices in Church**

Notices are now given prior to the start or before the last hymn at the 10:30 a.m. service each Sunday. Please remember that there are usually newcomers and guests in church. If you give a notice, begin by introducing yourself and say which group in church you are representing. Please also start with the subject of the notice (e.g. quiz night or opportunity to volunteer etc.). Verbal notices are important and you may need to give the notice on more than one Sunday. To get your notice into the weekly pew sheet, which is particularly important if it is to reach those attending the 9:00 a.m. or 4:00/6:00 p.m. services, please contact Emma by email in the church office in plenty of time. Your notice is much more likely to be read if given several times, ideally three weeks, two weeks and one week before the event in question. We ask that, except in special circumstances, written notices are under forty words.

We wish to thank members of our church for their help in gradually increasing the clarity of communication. Do please contact me if you feel that there are further improvements that we should consider.

## **Church Insight**

At the end of 2014 the Church Council approved a trial of Church Insight which Adele wrote about this in our church magazine. This cloud-based information system would allow us to have:

- An online address book
- Individual user accounts for those who want to update their own information
- Mailing lists for emails and letters
- Easily accessible Rotas for all our groups managed online
- Electronic reminders for those on rota who want them
- An integrated calendar linking groups, their web pages, and members
- A website that can be maintained group by group, using a web-browser from any computer.

## **Key Issues and Decisions**

### January:

Following the Diocesan request that all parishes contribute an additional £200 to address the shortfall in the Parish Offers for 2014 (and a major deficit on the planned Diocesan budget), members agreed that this extra amount be paid.

Members voted to continue with the trial of offering grape juice as a non-alcoholic option to communion wine at the 10:30 a.m. Sunday service and to review again in July.

### February:

Proposal accepted to reduce PCC meetings from 9 to 6 per year, in addition to the APCM in April, but to continue holding monthly Standing Committee meetings and extraordinary meetings if necessary.

A re-drafting of the 'Safeguarding Children and Young Persons' policy was completed and considered.

The PCC's prayerful consideration of the changes facing the churches of the Ashby & Breedon Team, prior to Rev'd Brian Robertson's pending autumn retirement, began. A grant application was submitted to 'Porticus' for funding on CAP's behalf.

March:

Details of the new Alpha Course, to begin in April 2014, were publicised.

April:

13<sup>th</sup> April: Annual Parochial Church Meeting held. PCC members and Church Officers appointed.

May:

PCC's introduction and welcome to Adele Adshead, prior to her becoming an SSM Curate at Holy Trinity for a 3 year period, following her ordination in June.

A re-drafting of the 'Policy concerning the Protection of Vulnerable Adults' was completed and considered.

Rev'd Tim confirmed that a meeting of the Archdeacon, the Area Dean, Clergy and Churchwardens for the Ashby & Breedon churches was to be held on 12<sup>th</sup> June, to consider ways forward for the Team.

Members voted to approve a limit of a 3.5% increase in the Parish Contribution offer for 2015, bearing in mind the monies still required to repair the church roof and to restore the organ. PCC voted to be supportive of Cheryl Butler in her venture to raise monies for CAP, by opening and running a stall in Ashby Market.

July:

PCC approval given for the treasurer to apply for a £500 grant under Tier 1 of the Leicester Diocese Growth Fund for the ongoing work of the Soul Café.

'Butler's CAP' stall now running in Ashby Market with all proceeds (and from eBay sales) going towards CAP.

£250 grant awarded from the 'World War I Event Growth Fund' for the purchase of Gospels, for a WWI service on 4<sup>th</sup> August.

'Songs of Praise for Seafarers' evening service held on 14<sup>th</sup> July, led by Iris Holt and Jean Holt. In view of favourable responses to offering the option of non-alcoholic communion wine at the main Sunday service, members voted for the practice to continue.

Approval given for appointing a Foodbank Centre Manager/Coordinator for 1 day per week, to manage the distribution centre and to support the volunteers.

September:

Diana Saunders' proposal for the next Churchwardens' Trip - an outing to Coventry Cathedral on 7<sup>th</sup> November - was warmly welcomed.

Considerable maintenance work had been carried out in the church hall during the summer break.

LED floodlights and LED spot lights were installed in the chancel and over the raised dais. An additional fire extinguisher was installed in the Tower Room.

## GOD ROCKS CAFE

God Rocks Café continues to serve as Holy Trinity's **Junior Church**, meeting in the church hall (on the 2<sup>nd</sup>, 3<sup>rd</sup> & 4<sup>th</sup> Sundays) at the same time as our 10:30 a.m. Morning Service. It caters for school aged children from 5 -14 years with a mixture of activities which range from games, worship, prayer and bible teaching to group work with activity sheets. It aims to be very much a part of the church family, joining the congregation on the 1<sup>st</sup> Sunday for the Family Service as well as on the 5<sup>th</sup> Sunday and during some school holiday periods.

Both the 5 - 8 year old and the 8 - 11 year old groups use the Scripture Union teaching programme. These two groups meet together for the first thirty minutes when the theme of the week is introduced, followed by bible teaching and worship and games played. After a short break the two groups then meet separately in order to do some group work and complete their age-related activity sheets. We have continued to work as three teams, with each team being responsible for one Sunday a month, thus enabling leaders to worship with the main congregation on the Sundays when they are not on duty. For much of the year we have struggled to recruit new leaders/helpers but thankfully our prayers and appeals have begun to be answered and people are beginning to step forward. This should enable us to continue to run God Rocks Café for the 3 Sundays a month that we currently offer.

The group for 11-14 year olds is led by Rev'd Paul Harris and Phil Taber. The bible study and teaching done in this group is aimed at helping these youngsters grow in their relationship with Jesus and apply their faith in their everyday situations. I would particularly like to commend this group for organising the cake sale which took place in church after the service on February 22<sup>nd</sup>. This was very much their own idea and they raised a total of £204.09 for the Audio fund. Well done!

In December God Rocks Café was once again very much occupied with rehearsals for the annual **Christmas Nativity** which was staged in church on Christmas Eve in front of a full church. Under Sandra Harris's organisational skills it was a great success and it was particularly encouraging to see our 11-14 year olds stepping up and taking the lead, both in terms of acting/narrating, as well as on the sound desk

God Rocks Café ministers to an average of thirty children and young people each Sunday. The **vision** that drives the leaders is to see each one come to a living faith in Jesus that is lived out on a daily basis and which can impact their families and friends. Please continue to pray for our work, especially that those who have offered their help will enable our teams to be strengthened.

## NW LEICESTERSHIRE DEANERY SYNOD

Holy Trinity Synod representatives remain unchanged and are: - Tim Phillips, Iris Holt, Frank Bedford and Carole Timms. Vivien Elphick is our area Dean.

Synod met three times last year in February, June and November. Our venues are spread out amongst the deanery and we met last year at:

- S. Denys Church, Ibstock,
- Broom Leys Church Hall, Coalville
- S. Margaret's School, Blackfordby

The meetings are well attended with a full agenda; most of the items on the agenda are linked with developing the 2020 vision plan. During our quarterly meetings last year we had the following items on our agendas to discuss:-

- Safeguarding policies and promoting a safe environment for children and vulnerable adults.
- Strategy focus areas of our 2020 plan to include buildings, working across boundaries (mission partnerships and the development of parish gift offers)
- Whole church ministry.
  - a) Patterns of baptism, confirmation and nurture and allied to that our deepening of discipleship in the area of our financial giving.
  - b) Development of the parish gift process, and allied to that our deepening of discipleship in the area of our financial giving.
- Women and the Episcopate - Background notes.
- Adrian Plass weekend.
- Moving from vision to reality - managing change.
- Growth fund, three million pounds that has been set aside by the Diocese to be used for church growth.
- Outing to Leicester Cathedral - Sunday May 10th 2015.
- Non Stipendiary Ministry.
- A Christian presence in every community.

At each of the meetings we were divided into small groups which included synod members from different benefices. We were then given relevant topics from the agenda to debate; the content of the discussion was recorded by a facilitator. The synod members then regrouped for feedback and the facilitator's relayed back the information gathered. These sessions have proved to be very useful and informative, especially so for the smaller village churches, a helpful exercise to all members as we are able to pool ideas, the information was collated then sent out to synod representatives to take back to our respective PCCs for discussion.

## HOLYWELL FIRST PASTORATE

What is now referred to as the **HTF PASTORATE** started in September 2014 - meeting fortnightly in Church on Thursday evenings. The Pastorate grew out of the **Holywell Life Group** which aimed to be local expression of Holy Trinity Church at 'small group level' with a membership of 14 people. This group was asked to provide the team to lay on an **Alpha Course** which was held from Easter to July in 2014. Through this course a number of people came to a new place in their relationship with Jesus and the church. The Pastorate was established as a 'post Alpha' group drawing on the experience of the home church of Alpha: Holy Trinity, Brompton.

The Pastorate aims to be, '**A Community of Disciples making Disciples**' and recognises the advantages of being a 'mid sized group' of 25 to 35 members which can provide easy access into the fellowship life of our church for both newcomers and longer-standing church members. Particular concerns of the Pastorate are:

1. To promote strong **friendships** by creating informal spaces for sharing (and eating) as well as for participating in small ad hoc groups.
2. Helping people to **grow as disciples** of Christ through life related Bible talks and group sharing along with different approaches to prayer and worship. An important aspect of this is creating opportunities for each one to discover and exercise their **gifts and ministries**. We have identified over ten different tasks and roles which are needed to enable the meetings and activities to function well (from catering to giving talks and from technical support to leading different kinds of worship). The aim is to help as many different people as possible to 'have a go' at as many different tasks as possible over a period of time.
3. Developing a focus for **mission and service**. The Pastorate aims to be a resource group for staffing nurture courses such as Alpha and Emmaus. In addition we are looking to encourage a culture of welcome and invitation as we provide a place where people within the orbit of Holy Trinity can find and follow Christ.
4. Fostering **smaller groups** to meet on the alternate weeks to the main pastorate gatherings. In this respect we have been glad to welcome the 'Go Deeper Bible Study' group to become part of our Pastorate and other members have started a group for prayer and listening.

One highlight for the Pastorate was to provide support and encouragement for several of our members who made a confession of faith at the **Adult Baptism and Confirmation/Reception Services** held at our church in November.

We extend a warm welcome to anyone who is looking to 'belong' in a deeper way to give us a try one Thursday evening.

## **ASHBY FOODBANK**

The aim of Trussell Trust/Ashby foodbank is to show the love of Jesus reaching out to others by providing emergency food and support for people in crisis.

Ashby foodbank is committed to staying in partnership with Trussell Trust until May 2016. Training continues to be provided for the Management Board, volunteers, and referring agencies as required. We now pay the reduced fee of £350 per year for these services.

Housed in the Congregational Church the foodbank is open on Tuesday mornings from 9:30 a.m. until 11:30 a.m. and on Fridays from 2:30 p.m. until 4:30 p.m.

The extent of our area is roughly everywhere within a boundary formed by the A42/A50 and A444; we are looking to extend our reach by contacting possible referral agencies within Burton upon Trent.

The Management Board continues to be chaired by Rev'd Tim Phillips and meets every four to six weeks. Changes to the board during the past year included Helen Child stepping down as Project Manager due to illness and pressure of work. We are thankful that she has remained a board member and that we are still able to draw on her extensive expertise. Jean M Harrison has taken over as Treasurer and Jean J Harrison joined as Minute Secretary. With regret we said goodbye to Polly Sherriff who helped to set up the foodbank and has given many hours service to the board and as an active volunteer. We thank Polly sincerely for her time with us. Finally, towards the end of the year, we were delighted to welcome Rev'd Catherine Booton as a board member.

We were fortunate to secure the services of Mick Redfern for three months as Foodbank Coordinator and were very sad when this job came to an end. The board and volunteers very much enjoyed the time that Mick was with us and thank him sincerely for the time he spent working for foodbank.

As we approach our second anniversary in May 2015, the foodbank continues to be well supported by all of the Churches in Ashby, as well as many in the immediate surrounding area, all of which provide a plentiful supply of donated food items and toiletries.

We are blessed with a good team of volunteers of many different faiths and none.

During each session we need six volunteers, two or three will work in the stock room where jobs include rotation of stock so that it is used in date order, weighing in any new stock that has been donated, and updating the in house records. In addition, when a client arrives with a voucher, volunteers will make up food parcels, weigh the food out, and again update the stock record. This data is also recorded on the confidential Trussell Trust Cloud Data System by Nikki Eccersley, the Distribution Manager.

Each food package will be made up of tinned or dried food and UHT milk, enough to feed each family member well balanced meals for three days. In addition, other goods such as toilet roll, toothpaste, soap and other essentials are included if they are available, and baby milk is bought as and when required if not in stock or if a special brand is requested.

We are now welcoming many more local families who, through little or no fault of their own, are living below the poverty line or struggling to feed their families mostly because of debt, illness, delays to benefits, family breakdown or redundancy.

Anyone visiting the foodbank will have been referred by a professional agency and issued with a voucher. This, when presented at the foodbank, will be exchanged for three days food (ten balanced meals) per family member.

Tim Abbott continues as our Referrer Relationship Manager and is increasing the number of agencies holding referral vouchers, keeping in contact with them to ensure that the system continues to work well.

During the year 412 adults and 409 children were fed equating to 8210 meals being distributed.

No major fundraising events took place in 2014 but we have continued to receive the top-up donation from Tesco based on the weight of goods collected in Tesco Extra Ashby. We share the in-store permanent collection box and National Collection (twice a year) with Coalville foodbank which works well for both foodbanks.

Thanks to the generosity of the Congregational Church we now have a permanent warehouse making management of the stock much easier and we still have a surplus of some goods which will be distributed to other local foodbanks. The warehouse is managed by Wendy Fielding who has a very loyal and efficient team of volunteers.

The present food stock stands at 6345.9kg (approx. £10,000) we are grateful for the regular donations received from individuals, churches and corporate organisations which maintains the stock level fairly constant.

In July 2014 Susannah Brook, East Midlands Area Manager for Trussell Trust, carried out our first Annual Quality Assurance Review and we achieved a very high standard with only minor details to follow-up on.

The Management Board would like to thank everyone for their on-going support and we look forward to another successful year in 2015.

## **CHRISTIAN AID**

The total amount raised by the Ashby and District churches in 2014 was £10,587.23, a small decrease of £308 compared to last year's best ever result.

The house-to-house collection was £7,846.86, a £360 increase on last year. £3,198.42 of this sum was gift-aided, which will result in a further £800 towards the work of Christian Aid.

Holy Trinity's thirty two collectors, a really encouraging increase from the twenty four in 2013, collected £1,534.41, an increase of £274. ## **CAP DEBT HELP**

This has been a great year of change, and challenges, not only for myself but also for CAP.

With Lisa Noon stepping down from the post of Centre Manager after three and a half years of dedicated service to God and the church, I have found myself with a God given opportunity to carry on the awesome work that Lisa and the rest of the CAP team started those years ago by taking on the role of Centre manager.

Having worked for the CAP debt centre now for just over 15 months I can, with hand on heart, say that we do genuinely save lives. Not only physically, but also spiritually. Many of the clients we see, cannot see a way out of the situation they find themselves in and 40% of the clients we see have thought about suicide.

2500 families went debt free last year, that's 10 families every working day (Praise God). Debt Coaches and Centre managers walked into 6,169 homes in 2014 to give our clients hope, and the support they needed to get out of the unmanageable debt they found themselves in.

Above all, 792 made a commitment to start a personal relationship with Jesus Christ.

We genuinely cannot do what we do without the support of the churches and we now have an amazing 270 Debt Centres working out of churches all over the country.

This is thanks to all the amazing people that support the work we do, whether it be financially, prayerfully or voluntarily, we cannot do it without you.

We do indeed serve an awesome God, and it is a privilege for me not only to serve God in this way but also the church, Thank you.

## **CAP JOB CLUB**

God has been at work throughout this second year of Holy Trinity opening our weekly Job Club. The commissioning prayer was from Isaiah 58:11 - *'You will be like a well-watered garden, like a spring whose waters never fail'*. Come and visit us between 9:15 a.m. to 12:15 p.m. on Thursday mornings and meet our community of members and volunteers and you will experience the answers to this prayer. You may not be able to distinguish between members and helpers, because our members are supporting each other in such an incredible way. Our blind friend is being taught to play the piano by someone who has discovered a God-given gift of teaching musical skills. His new Guide Dog is enjoying the music as much as we do! Some of our 'regulars', who are not available to work because of ill health, are updating skills in IT, Reading, English and Maths and one member regularly tutors another on the homework.

Christians Against Poverty encouraged us to establish a club where people could 'be themselves' and regain confidence which can be knocked through unemployment, redundancy, illness, disabilities and isolation. We offer prayer ministry and a confidential ear too. God sees the person He created in His likeness and we have the privilege of building up relationships of trust and love with His people.

As a Job Club we offer the full range of job seeking skills (CV's, online applications, interview practice, self-employment). Since opening on 11 April 2013 we have had 61 people through the door and seen a third of these into some form of paid/voluntary employment which suits their needs. One has set up a successful venture upcycling clothes vintage-style (we have their business card if anyone is interested). We have also found ourselves assisting with completing the lengthy forms for benefit assessments and 'Fit for Work' medicals.

The club has just celebrated the safe arrival of a healthy baby boy, with Mum working with us to assess her skills and suitability for jobs after maternity leave. Another has started to write her life story with the intention of seeking some way of publishing it. God is full of surprises for us and one meeting is never the same as the next, though the kettle is always on! Please encourage people to join us.

The words 'unemployed' and 'redundant' don't feature in The Bible. Similarly, they don't feature in our vocabulary in the CAP Job Club.

# TINY TOTS

***'From the lips of children and infants you have ordained praise'***

Tiny Tots continues to meet every Monday during the school term at 2:00 p.m. in Holy Trinity Church.

We are a group that welcomes children from birth to school age, along with their parents, grandparents or carers.

We begin with a time of praising God with flags as we march around the church. We then give thanks for birthdays and special occasions with the lighting of candles. It is lovely to see their little faces aglow in the candlelight as they sing 'Thank you Jesus' before they blow them all out. Some are able to sing by themselves too.

It is then prayer time when we say thank you to God for all He does and gives to us. When you are aged two, three or four, parties, visits to the zoo and visits from Granny and Grandpa are very special along with the important 'new shoes'. We then ask God for help for ourselves or for other people. During this time the children and adults hold a 'prayer bear'. Mums and carers also bring along their prayer requests and it is lovely that they are able to talk to God along with their children and we hope this will lead to prayer being a natural thing in their daily life.

We have kept to the same format at Tiny Tots for a few years as we know the children feel safe and at home with this. One of the favourite things they like to do is dance to the 'Wiggle Wiggle' song which we have before the story. Even the young babies react to this. Our stories are always from the Bible and are told in various ways. We then have a song, usually to a CD but sometimes Lorna plays the piano and the children love to watch her playing. We do craft and colouring each week which ties in with the story. After our final prayer 'Jesus friend of little children' we go and do our craft and have a well earned drink and biscuit. We have an area for the children to play and for mums and carers to have a chat and get to know each other and us better. The church aisle has proved to be a good place to practise walking and crawling.

Once again at Harvest Time we collected biscuits to take to one of the local care homes. This year we took some to Ashby Court in a box decorated by the children.

In December we were invited to join Smisby Day Nursery at their annual Christingle Service and to take part in some of the singing. It was a lovely occasion and some of the Tiny Tots team provided refreshments afterwards.

In the evening we had a fantastic meal, to celebrate our 10<sup>th</sup> Anniversary, at The Moody Cow restaurant at Upton Bishop and, for those who were able to stay, we walked to a Cider Farm on Sunday. We have welcomed 3 new members on our walks this year.

We are a friendly group of all ages and new members are very welcome - either regularly or for the 'one off' walk. Following our walks we enjoy a well-earned cuppa and home-made cake (donations welcomed for the work of Ashby Youth for Christ) before making our way home. This year we are planning to revisit more of our favourite walks and will also be trying out some new ones too.






## Port news

### Auckland, New Zealand:

Port chaplain, Revd Khaw Cheng Cheen, has started to build a community in the Port of Auckland. During his time with the Mission, he has had the opportunity to get to know some of the seafarers, whose ships dock at the Port of Auckland on a regular basis. This has in turn created a sense of community in the seafaring centre and aboard the ships Revd Cheen visits. He said it has been a "delight" to foster those friendships and trust during his months at the port, where he has come to know many of the seafarers he is serving. This leads to open communication between the chaplain and the seafarers. It can be difficult for most chaplains to build a community in their port due to the fast turnaround of ships, but when the opportunity to form those relationships arises it can greatly benefit the seafarers and the chaplain. ■

### Hong Kong, China:

The Revd Stephen Miller, Regional Director for East Asia, was invited to give an introductory course on the MLC 2006 to the Vietnamese Flag State Control (FSC) and Port State Control (PSC) inspectors. The course, which ran between 17 and 22 November in Da Nang, Vietnam proved very successful and Revd Miller has been invited back again in 2015. He hopes to build on recently formed relationships and move forward with providing welfare provision in Vietnam in the near future. ■

### Busan, South Korea:

The fishing trawler Oryong 501 sank off Russia's far eastern Chukotka peninsula after it encountered rough seas on 1 December. 60 men were on board the vessel, comprising of 35 Indonesians, 13 Filipinos, 11 South Koreans and one Russian. The search for survivors was been hampered by difficult weather and water conditions, and so far at least 35 bodies have been recovered since an initial seven people were rescued. Mission Chaplain, The Revd Simon Ro contacted his chaplaincy team to discuss the matter and they visited Sajo Industries' office in Busan to offer crew's families counselling, comfort and spiritual support. ■

### Felixstowe, UK

The biggest container ship ever built arrived in the Port of Felixstowe in January. China Shipping Container Lines (CSCL)'s giant box ship, the CSCL Globe has an overall length of 400m, a beam of 58.6m and a depth of 30.5m. The vessel began its maiden voyage at Tianjin Port and called at Qingdao and Dalian. After Felixstowe, it headed to Rotterdam in the Netherlands and Hamburg in Germany for the 70-day voyage. Felixstowe Port Chaplain, Simon Davies, said: "...there has been a media frenzy here about the CSCL Globe, with VIPs, champagne receptions, guided tours and even drones with cameras flying around. Unfortunately it was not possible for any of the local chaplains to visit the ship. The security was really tight, and no-one was getting on board unless they had their names on the list. But the crew members visited the seafarers' centre in the evening, so their needs were met." ■

## PLANNED GIVING

ONCE AGAIN, A BIG THANK YOU TO EVERYONE WHO HAS GIVEN  
SO GENEROUSLY TO HOLY TRINITY CHURCH.

The total amount given to the church within the Planned Giving scheme and gift aided donations in 2014 was £75,214.94. The total amount on which Gift Aid tax could be claimed was £67,890.28, which includes Planned Giving, CAP and other funds such as the Church Roof, which resulted in cheques received from HM Revenue and Customs totalling £16,972.59. We were also able to claim on our small donations (GASDS), which totalled £1193.12 for the year.

1<sup>ST</sup> claim – Tax claimed for period 1<sup>st</sup> Jan – 31 December 2014: £ 4,308.51.

2<sup>nd</sup> claim – Tax claimed for period 1<sup>st</sup> Jan – 31 December 2014: £ 6,692.74

3<sup>rd</sup> claim – Tax claimed for period 1<sup>st</sup> Jan – 31 December 2014: £ 5,971.34

Total tax claimed for Year 2014: £ 16,972.59, GASDS: £ 1193.12; Total: £ 18,165.71

Total non-tax efficient donations for 2014: £ 7,308.66

**Please note that this total includes tax claimed on behalf of the CAP Fund.**

For comparison, the total amount of donations on which tax could be reclaimed in 2013 was £62,207.06, and the cheques received from HMRC totalled £16,850.93, including £1,250.00 GASD.

These figures reflect the church accounts year (1 January to 31 December) rather than the tax year (6 April to 5 April).

There are several ways in which gifts can be given within the Planned Giving Scheme, and I encourage everyone who is a regular member of the congregation to do so using one of the following methods:

1. Weekly envelopes
2. Monthly, quarterly or yearly standing orders
3. Regular cheques put into the white envelopes, please state on the envelope the church fund you wish to donate to (general, church roof, organ fund, etc.).

Forms for setting up standing orders, making one-off donations and making Gift Aid declarations are available at the back of the church, and can also be downloaded from the church website: [www.trinityclose.net](http://www.trinityclose.net) (please click on Giving).

I would also encourage everybody to use the Gift Aid envelopes at the back of the church when making donations for flowers or for any church fund, to enable the church to reclaim Gift Aid on them.

It is the responsibility of individual givers to ensure that the amount of tax they pay on their income covers the tax reclaimed as Gift Aid by the charities they contribute to. A further reminder of this will be included in the April 2015 magazine.

I report on the accounts of the Parochial Church Council of Holy Trinity Church, Ashby de la Zouch, for the year ended 31<sup>st</sup> December 2014.

The PCC are responsible for the preparation of the accounts and consider that an audit is not required for this year under section 144(2) of the Charities Act 2011 and that an Independent Examination under section 145(1) of the Act is needed.

It is my responsibility to

- Examine the accounts under section 145 of the 2011 Act in accordance with directions given by the Charity Commission.
- To state whether particular matters have come to my attention.

My examination was carried out in accordance with the general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the PCC and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, seeking explanations from you, the PCC, concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below:

**Financial Statements for the year ended 31 December 2014**

**ACCOUNTING POLICIES**

The financial statements have been prepared in accordance with the Statement of Recommended Accounting Practice :Accounting and Reporting by Charities (SORP 2005) issued in March 2005, Accounting Practice, UK Accounting Standards and the Charities Act 2011.

The financial statements have been prepared under the historical cost convention, unless otherwise stated. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

The activities of the Church Hall, the CAPMNF Debt Counselling Centre and of the Ashby food bank have been aggregated with the PCC accounts. The accruals basis of accounting has been adopted.

**FUNDS**

**Endowment funds** are funds, the capital of which must be maintained; only income arising from investment of the endowment may be used either as restricted or unrestricted funds depending upon the purpose for which the endowment was established. No endowment funds existed at the balance sheet date.

**Restricted funds** represent (a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest, and (b) donations or grants received for a specific object. or invested by the PCC for specific object. The funds may only be expended on the specific object for which they were given.

**Unrestricted funds** are general funds which can be used for PCC ordinary purposes.

**Designated funds** are sums set aside out of General Funds by the PCC for specific designated purposes. They can be transferred back to unrestricted funds at any time if the PCC so decides..

**INCOMING RESOURCES**

Planned giving, offertories, collections and donations are recognized when received. Tax refunds on the planned giving are recognized as soon as the amounts are claimable. Thus the amount receivable is shown under debtors. Interest is accrued. All other income is recognized when it is receivable. All incoming resources are accounted for gross.

**RESOURCES EXPENDED**

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The Diocesan Parish Share is accounted for when due. All other expenditure is generally recognized when it is incurred and is accounted for gross.

**FIXED ASSETS**

Consecrated and benefice property is not included in the accounts in accordance with s.96(2)(a) of the Charities Act 1993. The PCC has not included the Church Hall and associated land in the accounts as it is unclear to establish the ownership of the property and the valuation at the time of preparation of the 2014 financial statements.

Equipment used within the church and the parish office is depreciated on a straight-line basis over their useful life as disclosed under note 7 of the financial statements. It is the policy of the PCC to capitalize assets whose value is £500 or above. Individual items of equipment with a purchase price of less than £500 are written off when the asset is acquired.

**ROOF AND ORGAN REPAIRS**

Repairs to the roof and the organ of approximately £70,000 and £36,000 respectively are required, but these amounts have not been included in these Financial Statements as liabilities as the precise costs and their possible funding is not yet known.
